- 1. Performs the full range of journeyman level electrician tasks, including maintenance, installation and repair of secondary electrical distribution systems. Installs underground cable and conduit, runs overhead wire and conduit. Runs load tests, checks and corrects circuit malfunctions, etc., using a variety of test instruments to assist in specific operations.
- 2. Inspects electrical systems and appliances in offices, warehouses and other buildings to detect and correct malfunction. Replaces and/or installs wires, switches, outlet boxes, fuses, lightbulbs, heating fans, heating appliances, etc.., removes items and diagnosing trouble and making necessary repairs.
- 3. Operate a Lineman's bucket truck.
- 4. Incumbent will accomplish duties as they relate to power production and repair of real property.
- 5. Maintains power generation systems, electrical, hydraulic, rewind and pneumatic components.
- 6. Works as a member of maintenance team. Assists with plumbing, structures, POL and HVAC repairs, also performs other facility maintenance as assigned by the Maintenance Supervisor.
- 7. Works from simple sketches, blueprints, drawings, specifications, or similar guidelines.
- 8. Subject to call outs after normal duty hours to include weekends and holidays.
- 9. Ability to deal tactfully with others.
- 10. Performs other duties as assigned.
